1. I am aware that there is a risk of injury or illness (including COVID-19) during participation in sports events.
2. My child/ward does not show any symptoms related to COVID-19 or any other infectious disease (no fever above 38°C, cough, and shortness of breath).
3. My child/ward has no health contraindications to participate in sports training and competitions. I agree to perform all necessary procedures or operations in life-threatening or health-threatening conditions. The coach in charge of my child/ward will be:

Information clause:

1. The organizer, all people cooperating with him, and people associated with the organization and conduct of the tournament are not responsible for personal, material, or property damages that will occur before, during, or after the tournament. Participants take part in the competition at their own risk, and minors with the consent of their parents or legal guardians. Participants are civilly and legally responsible for all damages they cause.
2. Each participant declares that he/she is insured against the consequences of accidents.
3. Participants waive the right to bring legal or refund claims against the organizer (or people cooperating with him) in the event of an accident or damage related to the competition.
4. The participant or the reporting club acknowledges that in the event of an accident, he/she cannot make any claims against the organizer. He/she undertakes to comply with the orders of law enforcement agencies and the conditions of the regulations/organizational announcement. In matters not covered by the regulations, the Competition Manager decides.
5. At the time of registration for the competition, coaches, guardians, and athletes agree to the terms of participation.
6. Legal guardians of minors consent to the provision of personal data necessary to conduct the competition: surname, first name, year of birth, and degree. The organizer reserves the right to use the images of the participants in the competition in photographic materials, film recordings, and interviews with participants, as well as the results of the competition (statistics) with personal data, which may be used for promotional purposes of the competition in mass media and social media.
7. Participants, at the time of registration for the competition, express acceptance of this declaration and consent to the processing of their personal data for the purpose of implementing the event in accordance with the Act of May 10, 2018, on the Protection of Personal Data (Journal of Laws of 2018, item 1000, as amended).
